The Lake Trout Festival, Baraga County Next Gen Team, Baraga County Convention & Visitors Bureau, Keweenaw Bay Classic Affiliates and all its advertisers and supporters RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT IN CONSIDERATION for being permitted to participate in the "Keweenaw Bay Classic Fishing Tournament".

The Undersigned Participants:

1. I _____ AND EVERYONE ON MY TEAM/BOAT HEREBY RELEASE, WAIVE, DISCHARGE AND CONVENTANT NOT TO SUE The Lake Trout Festival, Baraga County Next Gen Team, Baraga County Convention & Visitors Bureau, Keweenaw Bay Classic Affiliates and all its advertisers and supporters, their officers, employees, any surrounding towns or cities, the State of Michigan, or volunteering guides and assistants. All for the purpose herein referred to as "releases" from all liability to the undersigned, their personal representatives, assigns, heirs and next of kin for all and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of undersigned, whether caused by the negligence of the releases or otherwise while the undersigned is participating in event.
2. HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releases and each of them from any loss, liability, damage, or cost (including attorney's fees) they may incur due to the presence of the undersigned participating in the event and whether causes by the negligence of the releases or otherwise.
3. THE UNDERSIGNED PARTICIPANTS agree that while participating in the event, the use of alcohol or any substance which affects the ability to operate or control his or her vehicle may be considered as hazardous to the health and safety of participants and spectators is strictly forbidden.
4. THE UNDERSIGNED AGRESS that he or she will not use or operate any vehicle in violation or contravention of any city, county, state or federal laws, statuaries, ordinances, or regulation and shall be personally liable for all fines and penalties for such violations. Proper safety gear is required for all models of transportation.
5. Hereby assumes full responsibility for and risk of bodily injury, death, or property damaged due to the negligence of releases or otherwise while participation in the event.

EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the following release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by law of the state in which it is operated in and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND IMDEMNITY AGREEMENT, and further agrees that no oral representation, statement, or inducements apart from the foregoing written agreement have been made.
